Terms and Conditions

- 1. The lease will be for a period of 5 (five) years only.
- 2. The firm/ tenant should install display boards in places monitoring the road and put up advertisement hoardings, LED display boards, signages, runners, lamp posts etc within the allotted space at KTDC Shopping Complex Kochi. The person/firm who quotes highest rate will be considered as successful bidder.
- 3. The base annual lease rent will Rs 40,00,000/- (Forty Lakhs) and offers below this rate will not be considered.
- 4. The firm or person, to whom the lease is awarded, shall have to execute an agreement within 7(seven) days on receipt of intimation from KTDC, in a stamp paper of worth Rs 200/-.
- 5. The period of lease will commence from the date of executing the agreement and monthly rent applicable shall be paid by the tenant with effect from the same date.
- 6. The tenant has to deposit an amount equivalent to three months' rent or Rs....../(Rupees only) which shall be released on termination of lease period if it is then found that there is no liability.
- 7. The rent shall be paid by the tenant to KTDC on or before 5th of every calendar month in advance. If default is committed by the tenant in making the payment on or before the 5th of every calendar month, interest at the rate of 18% from the 5th of the month till the date of payment of the amount defaulted shall also be paid by the tenant to KTDC. The default in payment of rent will be treated as breach of the terms and conditions of the agreement.
- 8. The leased out premise shall not be transferred or used for any other purpose other than advertisement purpose. In case the lessee violates the said provision the agreement will be cancelled and security deposit will be forfeited.

- 9. The lessee should make use of the space for advertisement as listed below:
 - a. Runners through the boundary of the yard 2.43 X .9 Mtrs 75 no.s (Approx)
 - b. Lamp Post with Fancy Light .9 X .6 Mtrs 36 Nos (Approx)
 - c. Large Flex Hoarding on both side of sales office
 - i. Facing the Broad Way of size 20 X 30 feet
 - ii. Facing Marine Drive of size 20 X 30 Feet
 - iii. On show wall of size 30 X 20 Feet 2 No.s
 - iv. On show wall of size 30×12 feet -2×10^{-2} Nos
 - d. LED Display Board facing marine drive of size 20 X 30 feet One no.
- 10. LED display boards shall be mounted and installed by the lessee at his/her own cost after ensuring structural stability at the space allotted as per dimensions specified in the tender documents. The lessee shall solely bear the risk and cost for installing LED display boards.
- 11. It is solely the responsibility of the bidder to visit the space and ascertain the suitability of the various advertisement options available at the premises and new additions if any required for fulfilling the operations which shall be installed at the cost of the lessee.
- 12. The advertisement of KTDC shall be displayed on the LED display boards between 7 pm to 10 pm on daily basis, for a duration of 15 minutes at a stretch or at various intervals as per mutually agreement.
- 13. The lessee shall maintain the three entrance gates at the Park Avenue road. The gates to the Marine drive, Taj Gateway and to the Broad way will have width of 30 feet (aprox).
- 14. The lessee shall maintain the walkway inside the runners in one-meter width on all the three sides except on the side of the Guest House and pave the walkway with lawn grass and garden plants to be planted in between.
- 15. The lessee shall maintain small garden with three benches at the West North end after proper approval from KTDC.

- 16. The lessee shall use only the leased area in the premise and only for installing display boards and not carry any other business.
- 17. The electricity expenses for the Hoardings, lamp post, LED displays boards etc have to be paid by the lessee. The No Objection Certificate (NOC) and necessary permission to take and continue the electric connection to display structures shall be given by lessor at all times, if such requests does not hampers the public interest of Corporation.
- 18. The lessee shall bear the complete project cost inclusive of taxes, licensee fee and statutory compliances. The lessor shall not bear any expenditure incurred in this connection.
- 19. The lessor shall give advertisement rights of the boards inside runners and hoardings to the lessee, for a period of 5 years only, with effect from the date of issue of the work order. The lessee shall not make any advertisement objectionable or detrimental to KTDC.
- 20. It is the sole responsibility of the lessee to obtain all licenses from the local authorities/ Government agencies before starting the work and the lessor will not responsible for any problem arising out licenses or permission from the authorities concerned. If the lessor is forced to remove any or all structures including the hoarding advertisement installed due to any issues connected with the local authorities, the Corporation shall not have any liability.
- 21. The lessee should maintain the fence and Shopping Complex ground in good condition with good aesthetic appeal for the entire period. The lessor shall not be liable to bear any expense for the maintenance/ restoration of KTDC Shopping Complex ground during this period. If the lessee fails to maintain the area in good condition, the Corporation shall have the liberty to cancel the agreement after giving one month prior notice.
- 22. The allotted premise will be in the possession of KTDC. The tenant should not make any claim on the premise or any equipment in the premises owned by KTDC.

- 23. During the tenure of the agreement the lessor may take up works of structural improvements of the existing premises, additional structure in the land of Shopping Complex without causing obstruction to the visibility of display structures erected by the lessee.
- 24. The lessee shall cease to use the premise on completion of 5(five) years or as mutually agreed up on and hand over it to KTDC Ltd. The agreement may be renewed for a further period of 2(two) years only if there are no arrears of rent and in accordance with the terms & conditions with a minimum hike of 25 % hike from the previous year's rent.
- 25. In case if lessee violates any of the conditions prescribed herein, KTDC shall be at liberty to cancel the lease of the area and resume it from the possession of the tenant forfeiting the security deposit.
- 26. KTDC shall be at liberty to proceed against the lessee in case of default in the payments of any amount due for its realization. Any expenses towards legal or any other charges that may be incurred by KTDC in this account shall be liable to be realized from the security deposit collected from the tenant.
- 27. KTDC shall forfeit the security deposit, if the tenant withdraw/ cancel the agreement on any reason before the expiry of the agreement period.
- 28. Firms/ Individuals who are facing or have faced legal action in connection with rent arrear for KTDC Shopping Complex and evictees are not permitted to participate in the tender process.
- 29. All decisions taken by the Managing Director or the Board of Directors of KTDC Ltd shall be binding on the tenant.
- 30. The EMD amount of Rs 50,000/- (Fifty Thousand Only) shall be paid online by SBI MOPS while submitting the tender.
