## Terms & Conditions

1. The rate shall be inclusive of all taxes, duties, loading, unloading charges, transportation, other incidental expenses and net for the supply at Waterscapes, Kumarakom. No escalation of rates will be allowed under any circumstances.
  2. All statutory deduction will be deducted from the bill and exemption if any shall be informed with supporting documents.
  3. The offer shall be valid for 60 days from the last date of submission of offers.
  4. The supply shall be effected within **20 days** from the date of receipt of order.
  5. The supplied Engine/OBM with accessories shall have a **minimum warranty period of six months** and the actual warranty period of system shall be clearly indicated in the offer.
  6. The leaflet bearing the complete technical specifications of the product shall be enclosed along with the offer.
  7. The supplier shall install the OBM on the vessel including necessary services remote control cables and steering controls for the smooth operation of boat at no extra cost. The supplier shall commission the system and successful trials shall be carried out.
  8. The supplier shall demonstrate/impart training regarding operations and other aspect to the crew
  9. 100 % of the payment shall be affected on satisfactory supply and trial. 5% of the amount including security deposit shall be retained as performance guarantee and shall be released after satisfactory completion of warranty/performance guarantee period.
