Terms & Conditions

- 1. The rate shall be inclusive of GST, duties, loading, unloading charges, transportation, other incidental expenses and net for the work at site. No rate escalation will be allowed under any circumstances.
- 2. All statutory deduction will be deducted from the bill and exemption if any shall be informed with supporting documents.
- **3**. The makes of AC units and stabilizers shall be from the approved makes mentioned in the BOQ.
- 4. The offer shall be valid for 30 days from the last date of submission of offers.
- 5. The work shall be carried within 10 days from the date of work order.
- 6. The warranty period of the supplied items should be a **minimum of 1 year** from the date of testing and commissioning and the actual warranty period of AC, PC Board, compressor and stabilizer etc shall be clearly indicated in the offer.
- 7. The leaflet bearing the complete technical specifications of the product shall be enclosed along with the offer.
- 8. The quotations shall be enclosed and submitted in a sealed envelope on which the name of work shall be clearly superscribed. Otherwise the quotations will be summarily rejected.
- 9. Payment Terms:- 100% payment will be passed on satisfactory supply, installation, testing and commissioning of equipments at site.
