### **GENERAL CONDITIONS**

We intend to procure Cleaning Compounds to various hotel units of KTDC Limited, under the following conditions.

- 1) Firm competitive tenders are hereby invited from reputed manufactures/suppliers/dealers/agents for the supply of Cleaning Compounds in time and in good conditions.
- 2) Tender documents will be submitted under 2 cover system, technical bid and financial bid in the website, etenders.kerala.gov.in
- 3) Tender forms can be downloaded from the website from 20/09/2019. Tender ID is 2019\_KTDC\_300324\_1. The cost of tender of Rs.2000/- plus 18% GST Rs.360/- i.e. Rs.2,360/- is to be paid online.
- 4) The Corporation reserves the right to refuse to issue the tender documents to any person or firm without assigning reasons for it.
- 5) **The required specifications are prescribed in the list. For all items the bid shall be for the superior quality. Sample of 5 nos. of any of the 5 items, each labeled with name, content and bidder's name should be sent by Post / Courier to the Chairman (Purchase Committee), KTDC Ltd., Mascot Square, Thiruvananthapuram - 695033 before the date prescribed for tender opening.**
- 6) Bidders should quote for all items. The bidder who quote lowest for maximum number of items will be awarded the tender. The awardee will supply the remaining items at the lowest rate quoted by other bidders. In case more than 2 bidders who have quoted lower rates for equal number of items, the contract will be awarded to the bidder who had quoted lowest rates for more higher value items.
- 7) The rates for Bed and Bath Linen and Table Linen to be quoted separately in BoQ1 and BoQ2.
- 8) **Tenders without product specifications and the required samples will be summarily be rejected.**



- 9) Samples should reach the office of the Chairman, Purchase Committee before the day fixed for tender opening.
- 10) Selection of suppliers will be made on the basis of experimenting the samples, along with the price bid. It is reiterated that the selection is based only on quality of content and price.
- 11) Each tender should be accompanied by an Earnest Money Deposit of Rs.50,000./- (Rupees Fifty Thousand only), which can be later be converted as security deposit, EMD shall be paid online by SBI MOPS, while submitting the tender. Payment made otherwise will summarizily be rejected. Each tender should also be accompanied by certificates from competent authorities showing the past experience of the tenderer in successful completion of similar supplies.
- 12) The payment of EMD is exempted to the firms who possess the MSME Certification and such certificates to be uploaded for the exemption.
- 13) Tenders which are submitted **without the specified E.M.D** or do not otherwise conform to the condition of this notification will be rejected.
- 14) Tenders will be considered firm for acceptance for a period of three months from the last date fixed for receipt of tenders. Bidders are not free to withdraw or modify the tenders during this firm period except on pain of forfeiture to the Corporation of the Earnest Money Deposited. **The tenderer shall sign all pages of tender form.**
- 15) The accepted tender form of the tender notification, conditions of this contract, specifications and general conditions shall form part of the agreement.
- 16) The Earnest Money Deposit of unsuccessful tenderers will be returned as soon as possible on completion of tender formalities. EMD of others will be adjusted against security deposit.
- 17) The tender should be free from errors and corrections. Errors & corrections if any should be made neatly and attested by the bidder. The number of corrections in each page of tender documents should be noted in words at the bottom of each page.



- 18) The tendered rates should be net rates inclusive of all taxes/insurance/packing/forwarding/freight charges/monogram printing charges and all other incidental charges if any. GST to be mentioned separately. Alternative proposals/rates are liable to be rejected.
- 19) The material shall be of the best quality and of the exact kind, quality and description demanded and if at any stage these are found unsuitable/sub-standard they shall be liable to be rejected by the Unit/Corporation, the decision shall be final and binding on the supplier. In case of any of the said material being rejected or being supplied as aforesaid, the Unit/Corporation shall be at liberty to purchase the same at the cost and expenses of the supplier and the supplier shall on demand, pay to the Unit/Corporation all such extra costs incurred on account of such purchases or all such extra costs shall be deducted from the security amount/running bills. **In case of repeated defaults, the Unit/Corporation reserves the right to terminate the contract and the supplier shall have no right to any compensation or damages in this regard.**
- 20) Any additional or extra item of supply made by the contractor without the written authority of the Managing Director or Officer authorized by him will not be paid for.
- 21) Technical bid of tenders received will be opened online on 09/10/2019 after 11. a.m by the Managing Director of the Corporation or any person so authorized by him to act on his behalf. **If the date for receipt and opening of the tenders happen to be a holiday or hartal, the same will be done on the next working day.**
- 22) Rates should be quoted strictly according to the unit of the measurement specified against each item. Bidders have to supply the items to the respective units according to the units' requirements.
- 23) The acceptance of this tender rests with the Managing Director of the Corporation who do not undertake to accept the lowest or any particular tender or assign any reason for the rejection of any tender. The successful tender will have to execute an agreement.



- 24) Any further information regarding this tender, can be obtained from the Office of the Commercial Manager, KTDC Ltd. at Thiruvananthapuram during working hours on any day prior to the last date fixed for receipt of the tenders.
- 25) The Managing Director will have full authority to award the contract for the tendered items on part or full and the number of units to which the supply is to be effected.

### **TERMS AND CONDITIONS**

- 1) The cost of tender document is Rs. 2000/- + 18% GST extra (i.e. Rs.2,360/-) (non-refundable) should be remitted online by SBI MOPS.
- 2) The tender should be submitted only in the prescribed form under 2 bids system published in the website [www.etenders.kerala.gov.in](http://www.etenders.kerala.gov.in).
- 3) The tender form can also be down loaded from the website: [www.etenders.kerala.gov.in](http://www.etenders.kerala.gov.in). The cost of the tender document should be remitted online by SBI MOPS.
- 4) The rates quoted shall be applicable to all the KTDC units in Kerala and Chennai.
- 5) The supply shall be made to the units as per the order. **Samples should be submitted before the date prescribed for tender opening.**
- 6) Any additional supply made by the suppliers without written authority of the authorized officer from KTDC, will not be paid for.
- 7) The Corporation has the right to let other suppliers in connection with this contract at any time, if found necessary. In case the tenderer refuses to accept the award or refuses to comply with any of the terms and conditions for the award of contract, the EMD shall be forfeited.
- 8) If the supplier fails to supply the agreed items in time, he has to pay the Corporation the cost of damage and loss occurred due to his delay. If he fails to pay this sum in time, such sum arrived at shall be recovered from the Security Deposit.
- 9) The Successful tenderer's EMD amount of ₹. 50,000/- will be treated as Security Deposit. No interest will be payable on the security deposit. Bidders withdrawing before the announcement of successful tenderers shall be liable to have his EMD forfeited. The security deposit shall be remitted and the agreement executed within 10 days of the receipt of the order.
- 10) EMD of unsuccessful bidders will be returned as promptly as possible, but not later than 30 days after the issuance of work orders to the successful bidder.
- 11) The successful bidder shall complete all necessary formalities as per rules before delivering the goods to our premises.



- 12) The KTDC Management reserves the right to modify any of the above terms and conditions on genuine grounds.
- 13) Payments will be made based on the acceptance of the conditions in tender.
- 14) The Corporation has the power to terminate the contract at any time, if found unsuccessful, and to award the contract to another agency, which cannot be questioned anywhere. The Corporation reserves the right to negotiate reduction in the rates or to reject any or all tenders without assigning any reasons.
- 15) In case of dispute or differences between the two parties arise during the course of contract, the same shall be referred to Civil Courts of Thiruvananthapuram and the jurisdiction of such matter will be at Thiruvananthapuram Courts only.
- 16) As per the agreement required to be signed, the management reserves the right to call upon the supplier to continue the supplies at the contractual rates for three months in excess of the contract period. Similarly the Corporation also reserves the right to defer the commencement of the supply period by three months.
- 17) A final decision on the order will be taken only after taking in to consideration of the quality of the material offered, through samples and the rates.
- 18) The filled in tenders should be submitted online in the website [www.etenders.kerala.gov.in](http://www.etenders.kerala.gov.in)
- 19) Any other conditions needed should be furnished in the tender forms specifically/separately, while quoting for the supply, which can be studied and conditioned, on at last date, if found reasonable by the KTDC Ltd.
- 20) The successful tenderer must give an undertaking that the supply will be provided as per KTDC Ltd's requirement and as per the scope of the quotation.
- 21) If the tenderer fails to supply any of the items as per quotations, the security deposited will be forfeited, in addition to other legal remedies available including of termination of the contract.
- 22) In case any losses/damages in transit of goods, the Corporation will not be responsible.
- 23) The successful tenderer will deliver the items to the units directly on demand of requirement.



- 24) The rates quoted shall include all applicable taxes, insurance, packing, forwarding, freight, monogram printing and any other incidental charges if any. A final decision on the order will be taken only after taking into consideration the rates and quality of the materials offered.
- 25) The supplier shall provide and deliver the supplies at the premises of the respective unit of KTDC Ltd. within the Kerala/Chennai at the agreed rates against the orders received from the units of KTDC Ltd. during the period of this contract. Samples shall be produced on demand for assessing quality for final discussion.
