

**TERMS AND CONDITIONS OF QUOTAION CUM AUCTION**

(To be submitted in cover -1 along with D.D properly filled up and signed)

1. Items mentioned will be sold in "AS IS WHERE IS" condition
2. Quotations should be in prescribed form issued from this office
3. EMD will be **Rs. 2000/- (Rupees:Two Thousand only)**
4. Quotations should be submitted in two cover system. **COVER 1** should contain the demand draft of any scheduled bank payable at Cherthala for **Rs. 2000/- (Rupees: Two Thousand only)** drawn in favour of **Kerala Tourism Development Corporation Ltd** and a signed copy of the terms and conditions as token of its acceptance. **COVER 2** should contain prescribed quotation form quoting the amount offered clearly, without any corrections or over writing and should be properly sealed.
5. Items can be inspected with the permission of the Manager, Kumarakom Gateway Resort during office hours.
6. Each quotation should be accompanied by Earnest Money Deposit of Rs. 2000/-(Rupees: Two thousand only) by demand draft of any scheduled bank payable at Cherthala in **COVER 1** along with the signed copy of the terms and conditions. The cover 1 should be super scribed with the name of the bidder and need not be sealed.
7. The amount quoted in the prescribed form should be in the **COVER 2**, properly sealed and super scribed with the name of the bidder. The **COVER 2** will be accepted only if the Cover 1 is proper as per the directions. The quotations form should be completely filled up.
8. The amount quoted will be excluding taxes. The bidder is liable to pay the taxes and cess as per rules, in addition to the bid amount quoted.
9. The Quotations forms and terms and conditions can be had from the office up to 10.30 am on 08.02.2024 by payment of non refundable amount of Rs 100 plus applicable taxes.
10. The Sealed quotations will be accepted up to 01.30 pm on 08.02.2024 at the office of the Manager, Kumarakom Gateway Resort, KTDC LTd, Thanneermukkom. Quotations will be opened only after the open auction scheduled to conduct at 02.00 pm on the same day in the presence of the available bidders. Only those people submitted the quotations with EMD will be allowed to participate in the open auction.





11. The highest offer from both the quotations and open auction will be accepted in normal course. But the Manager, Kumarakom Gateway Resort, Thanneermukkom reserves the right to reject any or whole offers without assigning any reason thereof.
12. Successful bidder should remit 50% of the amount quoted immediately on finalization of the highest bid, in addition to the EMD to be retained, failing which the bid will be treated as null and void and the EMD will be forfeited.
13. The successful bidder should remit the balance amount and applicable taxes within three days, failing which the EMD and already remitted amount will be forfeited. The items should be removed from the premises within 03 days from the date of auction. If the items are not removed within 03 days from the date of auction, a rent of Rs. 2000 per day will be levied.
14. The Demand draft for the EMD of the unsuccessful bidders will be returned to them immediately after the remittance of 50 percent by the successful bidder.
