TERMS & CONDITIONS OF QUOTAION CUM AUCTION KTDC/WS/G-9/5503/2020

1. Quotations should be in prescribed form issued from this office
2. EMD will be **Rs. 1000 (One thousand only)**
3. The item can be inspected with the permission of the Manager during office hours.
4. Each quotation should be accompanied by EMD of **Rs. 1000/-**-(Rupees: one thousand) by demand draft of any scheduled bank payable at **Kumarakom/Kottayam** along with the signed copy of the terms and conditions and quotation form.
5. The amount quoted will be excluding taxes. **The bidder is liable to pay the taxes and cess as per rules**, in addition to the bid amount quoted.
6. The Sealed quotations will be accepted up to 2.30 pm on **23.03.2020** at the office of the Manager, Waterscapes, KTDC LTD, Kumarakom.. Quotations will be opened only after the open auction scheduled to conduct at 3.00 pm on the same day in the presence of the available bidders. Only those people submitted the quotations with EMD will be allowed to participate in the open auction.
7. The highest offer from both the quotations and open auction will be accepted in normal course. But the Manager, Waterscapes, KTDC LTD, Kumarakom reserves the right to reject any or whole offers without assigning any reason thereof.
9. Successful bidder should remit 25% of the amount quoted immediately on finalization of the highest bid, in addition to the EMD to be retained, failing which the bid will be treated as null and void and the EMD will be forfeited.
10. The successful bidder should remit the balance amount and applicable taxes within three days, failing which the EMD and already remitted amount will be forfeited. The item should be removed from the premises within 7 days from the date of auction. If the item is not removed within 7 days from the date of auction, a rent of Rs. 500 per day will be levied.
