

Terms and conditions

1. The supply shall be completed within 15 days.
2. The offer shall be valid for 30 days from the last date for receipt of your offer.
3. The rate quoted shall be inclusive of all taxes, duties, incidental expenses, Transportation charges, loading, unloading, workers compensative, taxes on work contract etc are to be included in the quote and for delivery at site.
4. No escalation of rates will be allowed under any circumstances.
5. The supplied item should match with the specification in the schedule in all respects.
6. The equipment supplied at the site shall be installed / commissioned by the supplier at no extra cost.
7. The equipment shall have suitable lighting arrangements to have effective display of the item.
8. KTDC reserves the right to reject any or all quotations and cancel the quotationer process without assigning any reasons.
9. All resources (Men, Material, tools & equipments, power, fuel consumables, scaffoldings etc) if required has to be arranged by the firm.
10. The invoice shall be in GST format with GST numbers of both supplier and receiver to enabling availing credit inputs.
11. All statutory deduction will be deducted from the bill and exemption if any shall be informed with supporting documents.
12. Pro rata payment shall be made as recommended by the officer in charge. 5% of the amount shall be retained as performance guarantee for one year.
