Sealed competitive Quotations are invited from reputed individuals / firms / companies for the Drydock of the Safari Boat III (KIV/VZM/PV/0023/10) at Water Sports Veli as per the schedule attached and following terms and conditions.

Scope of work

The work includes carrying out the works as per the schedule including the dry dock survey by the statutory authorities after hauling up. If any additional works are insisted by the survey authority, the same shall also be carried-out.

Terms and conditions

1. The work shall be completed within 30 days.
2. The offer shall be valid for 30 days from the last date for receipt of your offer.
3. The rate quoted shall be inclusive of all taxes, duties, incidental expenses; loading, unloading, workers compensative, taxes on work contract etc other than GST is to be included and for work at site. GST shall be shown separately with the applicable percentage. Transportation cost if any shall be included in the respective rates.
4. No escalation of rates will be allowed under any circumstances.
5. The works shall match with the specification in the schedule in all respects.
6. KTDC reserves the right to reject any or all quotations and cancel the quotationer process without assigning any reasons.
7. All resources (Men, Material, tools & equipments, power, fuel consumables, scaffoldings etc) if required has to be arranged by the firm.
8. The invoice shall be in GST format with GST numbers of both supplier and receiver to enabling availing credit inputs. The GST number of KTDC is '32AABCK0385J1ZP'.
9. Necessary statutory deductions will be carried out from supplier's bill and exemptions if any shall be in informed in advance with necessary supporting evidence.
10. The successful bidder shall execute an agreement in Kerala stamp paper worth Rs. 200/- agreeing to the general condition of contract with a Security Deposit of 3% of contract value for the fulfillment of contract, if the contract value is over Rs.1.00 Lakh.
