It is proposed to arrange for the supply of **Uniform T-shirts** to KTDC Limited, hereinafter called the Corporation at Thiruvananthapuram.

1. Firm competitive tenders are hereby invited from reputed manufactures/suppliers/dealers/agents for the supply of the items on time and in good condition.
2. Tenders should be submitted intact in the prescribed tender forms in sealed covers and super scribed with the name of the supplier so as to reach the Managing Director of the Corporation hereinafter mentioned as the Managing Director on or before 17/11/2023. KTDC Ltd. does not take the responsibility for postal delay. Tenders should not accompany any request for negotiations from tenders. The technical and financial bids should be enclosed in separate envelops and clearly labeled.
3. Tender forms can be obtained from the office of the Operations Manager during working hours up to **5 P.M.** Prospective tenderers requiring the tender documents by post, the tender documents will be supplied by ordinary post in the address furnished. The Corporation does not undertake any responsibility for tender documents delayed or lost in transit. The tender form can also be downloaded from the website of KTDC Ltd. for downloading visit: www.ktdc.com/announcement.php and click tender If the tender documents are downloaded the cost of the tender shall be remitted along with tender bids by DD for Rs.2240/- favouring KTDC LTD. payable at Thiruvananthapuram.
4. The Corporation reserves the right to refuse to issue the tender documents to any person or firm without assigning reasons for it.

5. Each tender should be accompanied by an **Earnest Money Deposit of Rs.10,000.- (Rupees Ten Thousand only)**. This may be in the form of Demand Draft from any recognized Bank with a branch at Thiruvananthapuram, duly authorized for payment to the KTDC Limited, Thiruvananthapuram. Each tender SHOULD BE ACCOMPANIED ALSO BY CERTIFICATES FROM COMPETENT AUTHORITIES SHOWING THE PAST EXPERIENCE OF THE TENDERER IN SUCCESSFUL COMPLETION OF SIMILAR SUPPLIES. The EMD and the receipt of the tender cost should be enclosed along with the technical bid.
6. Tenders which are submitted **without the specified E.M.D by D.D** or do not otherwise confirm to the condition of this notification will be rejected.
7. Tenders will be considered firm for acceptance for a period of three months from the last date fixed for receipt of tenders. Tenderers are not free to withdraw or modify the tenders during this firm period except on pain of forfeiture to the Corporation of the Earnest Money Deposited. **The tenderer shall sign all pages of tender form.**

8. The accepted tender form of the tender notification, conditions of this contract, specifications and general conditions shall form part of the agreement.
9. The Earnest Money Deposit of unsuccessful tenderers will be returned as soon as possible on completion of tender formalities. EMD of others will be adjusted against security deposit.
10. The tender should be free from errors and corrections, if any should be made neatly and attested by the tenderer. The number of corrections in each page of tender schedule should be noted in words at the bottom of each page.

11. **The tendered rates should be net rates inclusive of GST/insurance/packing/forwarding/freight charges and all other incidental charges if any and supply to be made 3 locations, i.e. Kozhikode, Kalady & Thiruvananthapuram. 13. Sample swatches /pieces of the material with name, content and bidders name should be sent so as to reach this office before the date prescribed for tender opening. The material of the T-shirt supplied shall be of the best quality and of the exact kind, quality and description demanded and if at any stage these are found unsuitable/sub-standard at any stage of supply, shall be liable to be rejected by the Corporation, the decision shall be final and binding on the supplier. In case if any of the item supplied is being rejected or being supplied as aforesaid, the Corporation shall be at liberty to purchase the same at the cost and expenses of the supplier and the supplier shall on demand, pay to the Corporation all such extra costs incurred on account of such purchases or all such extra costs shall be deducted from the security amount/running bills.
14. The tenders received **will be opened at 4 P.M on 17/11/2023** the last date fixed for receipt of the tenders by the Managing Director of the Corporation or any person so authorized by him to act on his behalf, in the presence of such of the tenderers or their duly authorized agents. **If the date for receipt and opening of the tenders happen to be a holiday or hartal, the same will be done on the next working day.**
15. Rates should be quoted strictly according to the unit of the measurement specified. Tenderers have to supply the items to 3 locations i.e. Kozhikode, Kalady & Thiruvananthapuram.
16. The acceptance of this tender rests with the Managing Director of the Corporation who do not undertake to accept the lowest or any particular tender or assign any reason for the rejection of any tender. The successful tender will have to execute an agreement.

19. A bank Guarantee of Rs.10,000/- will be submitted by the selected tenderer for ensuring quality and prompt delivery. The EMD amount of Rs.10,000/- will be treated as Security deposit for the fulfillment of delivery of T-shirts.

20. The payment of EMD is exempted to the firms who possess the MSME Certification and such certificates to be uploaded for the exemption.

TERMS AND CONDITIONS

1. The cost of tender document is Rs.2240/- (non refundable).
2. The tender should be submitted only in the prescribed form issued from the office of the Operations Manager, KTDC Ltd., Corporate Office, Mascot Square, Thiruvananthapuram – 33
3. The tender form can also be down loaded from the website: www.ktdc.com. The cost of the tender document should be remitted along with the submission of tender by way of cash/D.D favouring KTDC Ltd. payable at Thiruvananthapuram.
4. The supply shall be made to the Regional Offices of KTDC Ltd. at Kozhikode, Kalady & Thiruvananthapuram as per the order. Samples should be produced along with the submission of tender documents. Tender will be finalized only on the verification and approval of the samples by the Purchase Committee.
5. The bidder should submit sample swatches/pieces of the material for lab analysis and the same should reach this office before the tender opening date. .
6. The financial bid will be opened only as receipt of lab analysis report of the samples submitted and final decision on the order will be taken only after taking in to consideration of the lab test results of the samples submitted and the rates quoted.
7. Any additional supply made by the suppliers without written authority of the authorized officer from KTDC, will not be paid for.
8. In case the tenderer refuses to accept the award or refuses to comply with any of the terms and conditions for the award of contract, the EMD shall be forfeited.
9. Supply of T-shirt to be made within 15 days on the receipt of confirmed order.

10. If the supplier fails to supply the agreed items in time, he has to pay the Corporation the cost of damage and loss occurred due to his delay. If he fails to pay this sum in time, such sum arrived at shall be recovered from the Security Deposit
11. The successful bidder shall execute an agreement within in 7 days from the date of receipt of the order accepting his/her bid. The Successful tenderer's EMD amount of Rs.10,000/- will be treated as Security Deposit. No interest will be payable on the security deposit. Tenderers withdrawing before the announcement of successful tenderers shall be liable to have his EMD forfeited.
12. The tender documents can be obtained from the office of the Operations Manager, from 01/11/2023.
13. The successful tenderer shall complete all necessary formalities as per rules before delivering the goods to our premises.
14. The KTDC Management reserves the right to modify any of the above terms and conditions on genuine grounds.
15. Payments will be made based on the acceptance of the conditions in tender.
16. The Corporation has the power to terminate the contract at any time, if found unsuccessful, and to award the contract to another agency, which cannot be questioned anywhere. The Corporation reserves the right to negotiate reduction in the rates or to reject any or all tenders without assigning any reasons.
17. In case of dispute or differences between the two parties arise during the course of contract, the same shall be referred to Civil Courts of Thiruvananthapuram and the jurisdiction of such matter will be at Thiruvananthapuram Courts only.
