# **Terms and Conditions**

- 1. The period of lease will be for a period of 11 months initially, which shall be renewed if mutually agreed.
- 2. On awarding the tender, awarded firm/person has to execute the lease agreement within 15 days on receipt of intimation from KTDC in a stamp paper worth Rs.200/-.
- 3. The lease awarded firm/person has to deposit an amount equivalent to 6 months rent as security deposit with KTDC which shall be released on termination of lease period if it is then found that there is no liability on tenants' side. No interest will be paid by KTDC for the security amount.
- 4. The rent shall be paid by the awarded firm/person to KTDC on or before 5<sup>th</sup> of every calendar month in advance. If defaulted by the tenant in making the payment on or before the 5<sup>th</sup> of every calendar month, interest at the rate of 18% from the 5<sup>th</sup> of the month till the date of payment of the amount defaulted shall also be paid by the tenant to KTDC.
- 5. The EMD amount of Rs. 25,000/- (Rupees twenty five thousand only) per shop by form of D/D in favour of KTDC Ltd. payable at Ernakulam should be enclosed with the tender form. Exemption for EMD will be given to agencies have MSME registration.
- 6. The tender forms without required EMD will be rejected.
- 7. The period of lease will commence from the date of executing the agreement and monthly rent applicable shall be paid by the tenant with effect from the same date.
- 8. The space leased out shall not be transferred or subleased by the tenant.
- 9. The tenant shall use the premises only for commercial shops and other legal establishments.
- 10. The tenant shall be responsible for the safe custody and proper upkeep of the area allotted during the entire lease period. All repairs and maintenance works required to be done during the lease period shall be attended by the tenant at his cost.
- 11. If the tenant is making any changes in civil constructions, the same has to be carried out at the tenant's cost and only with the approval of KTDC.
- 12. The tenant shall vacate the premises on completion of 11 months or as mutually agreed up on and hand over it to KTDC Ltd in its original condition.
- 13. During the lease period KTDC may take up works of structural improvements, additions etc. The tenant shall render all facilities for carrying out such works without raising any objection.
- 14. In case the tenant violates any of the conditions prescribed herein, KTDC shall be at liberty to cancel the lease of the area and resume it from the possession of the tenant forfeiting the security deposit.
- 15. KTDC shall forfeit the security deposit, if the tenant withdraw /cancel the agreement on any reason before the expiry of the agreement period.
- 16. KTDC shall be at liberty to proceed against the tenant in case of default in the payments of any amount due for its realization. Any expenses towards legal or any other charges that may be incurred by KTDC in this account shall be liable to be realized from the security amount or the advance amount collected from the tenant.

- 17. KTDC will not be responsible for any loss of goods due to theft, burglary or fire from the leased out area.
- 18. No explosives or unlicensed items of any kind shall be stocked in the leased out area.
- 19. Firms/Individuals who are facing pending legal action in connection with rent arrears for KTDC Shopping Complex and evictees are not permitted to participate in the tender process.
- 20. Persons / agencies participating for more than one shop, will be preferred over the person/agency for one shop, without compromising on the rates.
- 21. Minimum quotable rate for shop numbers 12,13,14,15,17,18,19 & 31 will be Rs 80 per sq feet and for Shop Number 7 will be Rs 180 per sq feet.
