## **EMPANELMENT OF FIRMS / INDIVIDUALS / CONSORTIUM FOR ESTABLISHING EV CHARGING STATIONS AT VARIOUS PROPERTIES OF KTDC**

### **SECTION 1**

#### **A. *OBJECTIVE***

The objective / requirement of this Expression of Interest is for Empanelment of suitable firms / Companies / Individuals for establishing EV charging stations on various properties of KTDC. The empanelment will be valid for 3 years from the date of selection.

#### **B. *SCOPE OF WORK***

**Scope of work is to establish the charging station at KTDC units which may include as follows**

1. Identification of Area for parking lot for charging in consultation with KTDC.
2. Providing / Installing necessary equipment / machines for charging station.
3. Preparing the ground for parking vehicles for charging
4. Providing separate electric connection for equipments.
5. Billing with customers
6. Obtaining necessary clearance / NOC/ permit for operating the EV charging stations from statutory authorities as required.
7. Obtaining necessary approval from KSEI for energizing the equipment
8. The charging station shall be equipped with fire-fighting equipments for safety and obtaining the clearance / NOC from fire department if required.
9. Clearance from KSPCB shall be obtained if required.
10. Clearance from Ministry of Environment & Forest may be obtained. (If applicable)
11. Compliance of all necessary statutes will be under the scope of the operator.

#### **C. *SCOPE FOR REVENUE***

1. The empaneled operators will be called for offers at its various destination properties on a revenue sharing basis.
2. The minimum revenue sharing shall be 10% of the revenue subjected to a minimum

monthly payment of Rs. 10,000/-

3. The operator at various destinations will be chosen from among the empaneled operator on the basis of competitive offer by a secondary bidding process based on the highest offer above the percentage fixed above (Base percentage fixed as 10%)

## **c. Minimum Qualifying Criteria**

### **1. Technical**

- a. The applicant should have a minimum experience of three years in the Automobile / MEP works.
- b. The applicant should have installed at least three EV charging stations individually or as a consortium within Kerala. The capacity of the Installation shall be not less than 60 kW at each location, or the applicant should have installed five charging stations of capacity not less than 30 kW.

### **2. Financial**

- a. The firm / Individual should be registered with the departments of Income Tax and GST
- b. The applicant should have an Average Annual Turnover of 20 lakhs for the last three financial years.

### **3. Organization**

- a. The applicant should have proven experience in establishing EV charging station which include layout planning, design of equipments etc. or should be an authorized dealer of such firms.
- b. The applicant should have workforce and infrastructure to take up establishment of EV charging installations and operation of EV charging station and its maintenance.
- c. The applicant should have experience in operation and Maintenance of EV charging station.
