Terms & Conditions

1. Preventive maintenance should be carried out once in a quarter with a total of 4 maintenance calls within the one year contract period.
2. Breakdown calls if any should be attended the same day on working days and within the next day in case of holidays.
3. Standby has to be provided in cases of delay in rectification.
4. Payment will be made quarterly after successful completion of each quarterly service and on production of bill along with supporting service bills duly certified by the System Analyst.
5. Spares required have to be changed without delay at no extra cost.
6. The rates are comprehensive and include all parts and consumables.
7. The firm is liable to check all UPS before entering into contract. Once the contract is entered all UPS will be deemed as working.
8. Both parties can terminate the contract with 1 month notice. The company will be liable for payment only till the date of contract. Any excess amount paid will have to be refunded in case of termination of the contract. The agency providing AMC will be liable to ensure that all machines are in working condition till the date of the termination of the contract.
